Early literacy training must be completed within 12 months of date of employment in the child care industry. Proof of completion may be documented on a certificate of course completion, classroom transcript, or diploma. Child care personnel must complete one of the following:

One of the Departments online literacy courses available on the Departments website.

One of the Departments approved literacy courses. A list of these courses can be obtained from the Departments website. (No additional courses will be approved by the Department.)

C. One college level early literacy course (for credit or non-credit) if taken within the last five years.
